ORDINANCE 1564-17

An Ordinance Granting a Zoning Petition for the Property at 29306 N. Darrell Road, Island Lake, Illinois

WHEREAS, the Village of Island Lake is an Illinois municipal corporation in Lake and McHenry counties; and

WHEREAS, the petitioner, Kemper Valve & Fittings Corp., has filed a petition with the Zoning Board of Appeals of the Village of Island Lake, for an amendment to the zoning map from E-1 Residence District to I-1 Light Manufacturing District, in regard to the following described property ("Subject Property"):

Lot 9 in School Trustee's Subdivision of Section 16, Township 44 North, Range 9, East of the Third Principal Meridian, in Lake County, Illinois

Address: 29306 N. Darrell Road, Island Lake, Illinois PIN 09-16-400-003

WHEREAS, a public hearing on said petition was held before the Zoning Board of Appeals of the Village in the manner and in the form as prescribed by Ordinance and statute and pursuant to proper public notice;

WHEREAS, as a result of the taking of evidence and the viewing of exhibits advanced thereat, the Zoning Board of Appeals of the Village of Island Lake did make the prerequisite findings necessary for granting of the zoning map amendment pursuant to the Village's Zoning Ordinance and pursuant to state statutes and did recommend to the Village Board of Trustees that the zoning map amendment requested be granted;

WHEREAS, the Mayor and Board of Trustees of the Village have considered the recommendations as submitted by the Zoning Board of Appeals; and

WHEREAS, the Mayor and the Board of Trustees have determined that it is in the best interest of the Village and in furtherance of the public health, safety, and welfare of the Village to grant the requested amendment to the zoning map.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Island Lake, Lake and McHenry Counties, Illinois, as follows:

SECTION 1: The recitals set forth hereinabove are incorporated herein as finding of the Mayor and Board of Trustees of the Village.

SECTION 2: The Mayor and Board of Trustees of the Village hereby grant the amendment to the zoning map from E-1 Residence District to I-1 Light Manufacturing District, for the Subject Property and hereby permit the temporary use of the Subject Property for agricultural use until such time as a building permit is issued relating to the Subject Properly.

SECTION 3: Severability. In the event that any section, clause, provision, or part of this Ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect.

SECTION 4: Repeal and Savings Clause. All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SECTION 5: Effective Date. This Ordinance shall be in full force and effect from after its passage and approval.
