***An Ordinance Prohibiting
Parking along Route 176
within the Village Limits
of Island Lake, Illinois***

ORDINANCE 1573-18

WHEREAS, THE State of Illinois acting by and through its Department of Transportation is desirous of improving Illinois Route 176 at its intersection with Roberts Road / Midway Road in the Village of Island Lake and,

WHEREAS, in order to facilitate the free flow of traffic and ensure safety to the motoring public, the Village of Island Lake determines that parking along Illinois Route 176 shall be prohibited,

BE IT ORDAINED BY THE VILLAGE BOARD OF THE VILLAGE OF ISLAND LAKE, COUNTIES OF LAKE AND MCHENRY, STATE OF ILLINOIS, as follows:

Section 1. That parking shall not be permitted along the ILLINOIS ROUTE 176 within the limits of the said improvement.

Section 2. That the Village Board of the Village of Island Lake will prohibit future parking at such locations on or immediately adjacent to Illinois Route 176 as may be determined and directed by the State of Illinois to be necessary to ensure the free flow of traffic and safety to the motoring public.

Section 3. The Village Clerk is hereby authorized and directed to attach a copy of the Ordinance to the agreement dated April 27, 2018 by and between the State of Illinois and the Village of Island Lake.

Section 4. That this Ordinance shall be in full force and effect from and after its passage and approval according to law.
