



## Village of Island Lake Lake Management Committee October 6th, 2016 Minutes 3720 Greenleaf Ave. Island Lake, IL 60042

- 1. Meeting called to order at 6:30pm.
- 2. Motion made by F. Burghardt and seconded by G. Nemeth to approve September 1, 2016 meeting minutes.
- 3. Village Board Meeting Update (K. Wick) No lake matters addressed.
- 4. OLD BUSINESS
  - a. ACTION Lakeside Property Identification: Motion made by F. Burghardt and seconded by Jen Villarreal for the LMC to recommend to the village board to pass an ordinance that would require residents to display lakeside property identification. The motion carried with no objections.
  - b. ACTION Fall Fish Stocking: Motion made by F. Burghardt and seconded by G. Nemeth to purchase 1,100 1,300 red ear sunfish per DNR's recommendation. The motion carried with no objection.
  - c. Clarke Aquatics Water Movement Presentation: Jennifer Biancalana , a representative of Clarke Aquatics provided information about water movement options to address the lake's water quality issues. Many aspects were discussed including the benefits of aeration, the different types of aerators (bottom diffusers/bubblers, surface fountains/volcanos and circulators/pushers), aerator placement/layout, electrical requirements, possibilities of pest damage, maintenance, pricing, budget approval and government regulations. LMC requested that Clarke Aquatics prepare a proposal appropriate for aerators located in Circle Bay, Forest Bay, Eastway Bay and Little Island Bay.

- 6. PUBLIC COMMENTS:
  - a. Sam Cicero Inquired about the ordinance proposal for lakeside property identification (i.e. size and/or design specifications, resident notification, enforcement...) The ordinance would be posted in the village newsletter, village website and notifications could be mailed via post. ILPD would be responsible for enforcement.
