***An Ordinance abating the taxes heretofore  
levied for the year 2018 to pay debt service  
on the General Obligation Waterworks  
Refunding Bonds (Alternate Revenue  
Source), Series 2014 of the Village of Island  
Lake, Lake and McHenry Counties, Illinois***

**ORDINANCE 1582-18**

*Abating the taxes heretofore levied for the year 2018 to pay debt service on General Obligation Waterworks Refunding Bonds (Alternate Revenue Source), Series 2014 of the Village of Island Lake, Lake and McHenry Counties, Illinois.*

WHEREAS, the Board of Trustees (the "*Board*") of the Village of Island Lake, Lake and McHenry Counties, Illinois (the "*Village*"), by ordinance adopted on the 22nd day of May, 2014 (the "*Ordinance*"), did provide for the issue of not to exceed \$1,175,000.00 General Obligation Waterworks Refunding Bonds (Alternate Revenue Source), Series 2014, and the levy of a direct annual tax sufficient to pay the principal of and interest on said bonds; and

WHEREAS, pursuant to the Ordinance, the Village has heretofore issued \$1,175,000 General Obligation Waterworks Refunding Bonds (Alternate Revenue Source), Series 2014, dated June 19, 2014 (the "*Bonds*"), and has filed in the offices of the County Clerk of the Counties of Lake and McHenry, Illinois (the "*County Clerks*"), a Bond Order for the levy of taxes to pay the Bonds; and

WHEREAS, the Village has Pledged Revenues (as defined in the Ordinance) on deposit in the Bond Fund Account, \$185,850.00 available for the purpose of paying debt service on the Bonds heretofore imposed by the 2018 levy; and

WHEREAS, such Pledged Revenues are hereby directed to be used for the purpose of paying debt service on the Bonds; and

WHEREAS, it is necessary and in the best interests of the Village that the taxes heretofore levied for the year 2018 to pay the Bonds be abated:

NOW, THEREFORE, Be It and It is Hereby Resolved by the Board of Trustees of the Village of Island Lake, Lake and McHenry Counties, Illinois, as follows:

*Section 1. Abatement of Taxes.* The taxes heretofore levied for the year 2018 in the Ordinance are hereby abated in their entirety.

*Section 2. Filing of Ordinance.* Forthwith upon the adoption of this ordinance, the Village Clerk shall file a certified copy hereof with the County Clerks and it shall be the duty of the County Clerks to abate said taxes levied for the year 2018 in accordance with the provisions hereof.

*Section 3. Effective Date.* This ordinance shall be in full force and effect forthwith upon its adoption.

*Section 4.* ADOPTED the 20th day of December, 2018 by a roll call vote as follows:


