In consideration of permission to participate in the Island Lake July 4th Parade other "recreational activities" the undersigned, individually or behalf of myself and as parent or legal guardian of named participating minor(s)(referred to, collectively, as "Releasor"), hereby agrees to release, covenant not to sue, and indemnify the Village of Island Lake, their board members, employees, representatives and agents, successors, heirs and assigns(referred to, collectively, as "Releasors") as follows:

- 1) Releasor understands that participating in Recreational Activities including but not limited to driving, walking and otherwise participating in the Recreational Activities which include hazards that expose the participants to a wide range of unknown and unanticipated risks that could result in physical or emotional injury, paralysis, death, dismemberment, loss or damage to the Releasor, to property , or to third parties.
- 2) RELEASOR ASSUMES FULL RESPONSIBILITY FOR THE RISK OF INJURY TO PERSON OR PROPERTY resulting from any of the risks associated with the one or more risks associated with one or more of the Recreational Activities including but not limited to: falls, Physical contact with other participates, tripping, misuse of objects, running, jumping, physical stress, inadequate warnings if risks, supervision or instructions by Releasors, actions or omissions by Releasees or any third parties. I also understand that inherent risks are present despite reasonable rules, procedures, supervision and safety equipment.
- 3) RELEASOR HEREBY VOLUNTARILY RELEASES, FOREVER DISCHARGES AND CONVENANTS NOT TO SUE RELEASEES for any and all claims, costs, expenses, legal fees, losses, damages, liabilities or injuries sustained by RELEASOR, and caused by any reason, including negligence, which may in any way arise out of, relate to, or be associated with the Recreational Activities.
- 4) RELEASOR SHALL DEFEND, HOLD HARMLESS AND INDEMNIFY RELEASEES from any and all claims, costs, expenses, legal fees, losses, damages, liabilities or injuries which may in any way arise out of, relate to or be associated with the presentation or prosecution by RELEASOR, of any claim lawsuit, allegation or action which is covered by this release, assumption of risk and covenant not to sue.
- 5) RELEASOR agrees to participate in the Recreational Activities only as permitted. In case of sickness, accident or injury, Releasees have Releasor's permission to secure, at Releasor's sole expense, such medical treatment as is deemed necessary in their sole discretion.
- 6) If any part of the provisions of this document is held unenforceable the balance shall be given full force and effect.

My participation & participation of any minors in these recreational activities is purely voluntary. I & my minors elect to participate despite the risks. I am aware this is a release of liability, a waiver of my & minors legal right to collect damages in the event of injury, death, or property damage , and an agreement not to sue Releasees, including the Village of Island Lake and I hereby sign it of my own free will.
