ORDINANCE 1593-19

An Ordinance Amending Title 1, Chapter 16, Annual Fee Ordinance, of the Island Lake Village Code Relating to Garbage Service Charges

WHEREAS, the Village of Island Lake is an Illinois municipal corporation in Lake and McHenry Counties and pursuant to the Illinois Municipal Code, the Village has the authority to modify the official Village code; and

WHEREAS, the Board of Trustees desires to amend the provisions of the Island Lake Village Code regarding annual fees; and

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Island Lake, Lake and McHenry Counties, Illinois, as follows:

SECTION 1: Title 1, Chapter 16, Annual Fee Ordinance, paragraph 1-16-3, Schedule of Fees, Fines, and Penalties, shall be amended as follows:

SECTION 2: Effective Date. This Ordinance shall take effect immediately upon its passage.

SECTION 3: Severability. In the event that any section, clause, provision, or part of this Ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect.


SECTION 4: Repeal and Savings Clause. All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

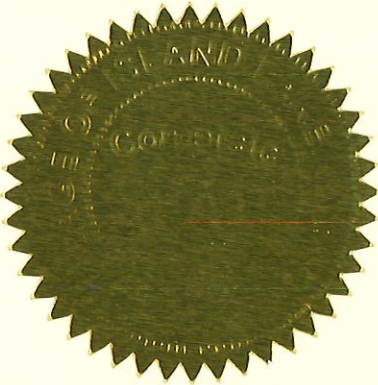


