- 1. Meeting called to order at 6:30pm.
- 2. Motion made by Dave Sobieski and second by Kris Munson to approve September 5th, 2019 meeting minutes.

## 3. OLD BUSINESS

- a. INFO: Hydrographic Survey/Sedimentation Study-Ken Wick. VOIL discussed at 9-26-2019 village meeting and trustees requested former studies of the health of the lake that have been conducted. 9 lakes study performed by the EPA and the Chicago Metropolitan Area of Planning (CMAP) and a study completed by the Lake County Health Department for Island Lake emailed to the board of trustees for review. See lower attachments. As you read the study, you will see that our lake falls into the bottom 10 percent when it comes to lake quality and is rated "Poor" by the Lake County Health Dept. The next VOIL meeting is 10-10-2019 and may be on the agenda. LMC Budgeted funds reallocated to cover the expense of the proposed survey.
- b. INFO: Duckweed Maintenance program-Ken Wick. Lake top treatment options explored with aquatic herbicidal agent called "Clipper" price per acer pending, requiring spot application monthly maintenance. Test area for Circle Bay proposed.
- c. INFO: Public request for University Involvement-Tané Howland. At the 9-26-2019 VOIL meeting, public comments requested outside help for the health of our lake from local colleges and universities. The LMC will respectfully ask Major Amrich to pursue the request of the people.

## 4. OTHER BUSINESS

a. INFO: Open for Members-The Island Lake Lions have announced the date of the 2020 Ice Fishing Derby to be Saturday February 1<sup>st</sup>, ice permitting. Options for catch containment of duck weed at the Mutton Creek intake area. Lake erosion prevention with possible home sale associated maintained sea wall requirement. Cut fish stocking this fall to fund the hydrographic survey/sediment study.
