**ORDINANCE NO. 1607-20**

***An Ordinance Imposing a Temporary Moratorium on the  
Additional Video Gaming Operations in the Village of Island Lake, Illinois***

WHEREAS, the Board of Trustees desires to impose a temporary moratorium on additional video gaming operations in the Village, to give the Village time to consider adoption of new regulations relating thereto; and

WHEREAS, six (6) existing businesses in the Village operate video gaming and Circle K is approved to do so (“Existing and Approved Licensees”).

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Island Lake, Lake and McHenry Counties, Illinois, as follows:

SECTION 1: A Moratorium, through March 11, 2021, is imposed on the issuance of additional video gaming licenses or operations within the Village beyond the Existing and Approved Licensees.

SECTION 2: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.


SECTION 3: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict. Where the provisions of this ordinance or any other Village ordinance establish or require different standards, the more restrictive standard shall apply.



## CERTIFICATION


