# ORDINANCE 1612-2020

## *An Ordinance Amending Title 2, Boards and Commissions, of the Island Lake Village Code*

WHEREAS, the Village of Island Lake is an Illinois municipal corporation in Lake and McHenry Counties and pursuant to the Illinois Municipal Code, the Village has the authority to modify the official Village code; and

WHEREAS, the Mayor and Board of Trustees desires to amend the provisions of the Island Lake Village Code adding a chapter to create an Advisory Parks Committee; and

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Island Lake, Lake and McHenry Counties, Illinois, as follows:

SECTION 1: Title 2, Boards and Commissions, Chapter 7, Advisory Parks Committee, shall be added as follows:

### CHAPTER 7

#### ADVISORY PARKS COMMITTEE

##### 2-7-1 **ADVISORY PARKS COMMITTEE**

- A. Appointment: With the advice and consent of the Board of Trustees, the Mayor shall annually appoint an Advisory Parks Committee which shall consist of interested Village residents. A Chairman shall be designated by the Mayor to oversee the Committee and a Secretary shall also be appointed to take meeting minutes.
- B. Members: The members of the Committee shall consist of not less than three (3) residents of the Village.
- C. Scope of Duties:

The Parks Commission shall have the following powers and duties:

  - (a) To make recommendations and otherwise provide advice to the Board of Trustees regarding the adoption and revision of policies and plans relating to the use and development of Village parks;
  - (b) To make recommendations and otherwise provide advice to the Village's Board of Trustees regarding necessary maintenance to parks;
  - (c) To make budget proposals relating to parks and other recreation areas in the Village and to comment on such proposals to the Village's Finance Committee;
  - (d) To search for and review funding grants relating to the Village's parks and to make comments regarding such proposals to the Board of Trustees;
  - (e) Subject to the authorization of the Mayor and Board of Trustees to undertake fund raising activities intended to be used to pay for improvements to the Village's parks;
  - (f) To provide assistance and advice when requested to Village officials and employees whose duties include management or maintenance of the Village parks;
  - (g) To work with existing local and regional organizations to promote the use and

development of park land and public conservation areas within the Village; and  
 (h) To perform such other duties and to undertake such other activities germane to the use and development of the Village parks as may be directed or suggested by the Board of Trustees. Recommendations of the Committees on all issues considered shall be transmitted in writing to the Village Board for further consideration and action.

- E. Meetings: The Advisory Parks Committee shall meet at least once every three months, in accordance with the Open Meetings Act.
- F. Bylaws: The Mayor and Trustees may, if necessary, adopt bylaws governing the Advisory Parks Committee.
- G. Attendance at Village Board Meetings: Upon request by the Mayor, the Chairman of the Committee shall attend and participate at meetings of the Village Board, in a non-voting manner.

SECTION 2: Severability. In the event that any section, clause, provision, or part of this Ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect.


SECTION 3: Repeal and Savings Clause. All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.



# CERTIFICATION


