ORDINANCE 1620-20

An Ordinance Repealing Ordinance 1565-17, 3210 Park Drive

WHEREAS, the Village of Island Lake is an Illinois municipal corporation (“Village”).

WHEREAS, an Ordinance granting a variance for the property at 3210 Park Drive, Island Lake, Illinois, was adopted as Ordinance 1565-17 on October 12, 2017.

WHEREAS, the Village Police Chief recommended repealing Ordinance 1565-17 and revoking the permitted parking variation granted thereunder; and written notice has been provided to Sean McDonald.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Island Lake, Lake and McHenry Counties, Illinois, as follows:

SECTION 1: Pursuant to paragraph F of Ordinance 1565-17, at the recommendation of the Village Police Chief, and following written notice being provided to Sean McDonald, Ordinance 1565-17 is hereby repealed, and the variation permitted thereunder is revoked.

SECTION 2: In the event that any section, clause, provision, or part of this Ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect.


SECTION 3: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.


CERTIFICATION
