### **GENERAL INFORMATION**

All registrations are processed on a first come-first served basis. The department reserves the right to cancel or consolidate classes depending on enrollment. A full refund will be issued for all cancelled classes. All classes are held at the Island Lake Village Hall, 3720 Greenleaf Avenue, except as noted in course descriptions. All participants must register through the Parks and Recreation Department, payment must accompany registration.

#### **PHOTO RELEASE**

During the session, there may be times when participants will be photographed. These photos may be used for decorating our bulletin board or other publicity purposes, as well as appear in our Recreation Guides. If you do not wish photos to be taken, please inform the Recreation Administrator.

### LATE PICK UP PROCEDURES

Parks and Recreation Staff cannot be responsible for children who are picked up late. A \$15 fee for every 15 minute increment will be charged, payable before the child can return to class.

#### **REFUNDS**

All Recreation classes are run depending upon enrollment numbers. All refunds requested must be in writing and are subject to a \$20 handling fee. If you choose to keep the credit on your account, the fee will be waived. NO REFUNDS are given after class begins. Refunds are processed through the Village's Administrative Department and may take 4-6 weeks to be mailed. If the Recreation Department cancels a class, a full refund will be issued.
