WHEREAS, on or about August, 2021, the Village received notice of an award of money totaling \$1,090,272.56 from the Federal Coronavirus Local Fiscal Recovery Fund established under the American Rescue Plan Act of 2021 (“CSLRF”) (“Released Funds”). The Released Funds were not available to the Village prior to July 31, 2021, and therefore not included in the 2021-2022 Appropriation Ordinance previously adopted by the Village.

WHEREAS, this ordinance will also establish budget items for a project(s) to be funded by the CSLRF. In FY 2021-2022, the Village of Island Lake anticipates receipt of the first installment in the amount of \$545,136.28 and the remainder within 12 months of the adoption of this Ordinance. The CSLRF funds received may be used for the following categories of expenditures, to the extent authorized by state law:

1. Support public health expenditures, by funding COVID-19 mitigation efforts, medical expenses, behavioral healthcare, and certain public health and safety staff;
2. Address negative economic impacts caused by the public health emergency, including economic harms to workers, households, small businesses, impacted industries, and the public sector;
3. Replace lost public sector revenue, using this funding to provide government services to the extent of the reduction in revenue experienced due to the pandemic;
4. Provide premium pay for essential workers, offering additional support to those who have borne and will bear the greatest health risks because of their service in critical infrastructure sectors; and
5. Invest in water, sewer, and broadband infrastructure, making necessary investments to improve access to clean drinking water, support vital wastewater and stormwater infrastructure, and to expand access to broadband internet.

WHEREAS, the Mayor and Board of Trustees desire to supplement the Village 2021-2022 Appropriation Ordinance Number No. 1632-21 to include the Released Funds now made available to the Village.

BE IT ORDAINED by the Mayor and the Board of Trustees of the Village of Island Lake, Lake and McHenry Counties, Illinois, pursuant to 65 ILCS 5/8-2-7:

Section 1: That the 2021-2022 Appropriation Ordinance No. 1632-21 is hereby supplemented and amended to reflect the following available revenue amounts appropriated and authorized for expenditure:

CSLRF Project for Water Main Replacement	\$545,136.28
CSLRF Project to be determined in FY 2021-2022	\$545,136.28

Section 2: The following revenues are anticipated to be available to complete the project:

CSLRF Funds \$1,090,272.56

Section 3: The Treasurer is hereby directed to maintain sufficient specific detailed accounting records to satisfy the requirements of the grantor agency and the grant agreements.

Section 4: The Treasurer is hereby directed to report the financial status of the project to the Village Board on a monthly basis.

Section 5: Copies of this Supplemental Appropriation Ordinance shall be furnished to the Treasurer, the Superintendent of Water and to the Village Clerk.

Section 6: A certified copy of this Supplemental Appropriation Ordinance shall be filed with the McHenry County Clerk and Lake County Clerk within 30 days after its passage.

Section 7: This grant project ordinance expires on December 31, 2026, or when all the CSLRF funds have been obligated and expended by the town, whichever occurs sooner.




