ORDINANCE 1638-21

An Ordinance Amending Title 1, Chapter 16, Annual Fee Ordinance, Water Service Charges, of the Island Lake Village Code

WHEREAS, the Village of Island Lake is an Illinois municipal corporation in Lake and McHenry Counties and pursuant to the Illinois Municipal Code, the Village has the authority to modify the official Village Code; and

WHEREAS, the Board of Trustees desires to amend the provisions of the Island Lake Village Code regarding annual fees and regulations; and

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Island Lake, Lake and McHenry Counties, Illinois, as follows:

SECTION 1: Title 1, Chapter 16, Annual Fee Ordinance, paragraph 1-16-3, Schedule of Fees, Fines, and Penalties, shall be amended as follows:




