# ORDINANCE 1648-22

## *An Ordinance Amending Title 1, Chapter 16, Annual Fee Ordinance, of the Village of Island Lake Code*

WHEREAS, the Village of Island Lake is an Illinois municipal corporation in Lake and McHenry Counties and pursuant to the Illinois Municipal Code, the Village has the authority to modify the official Village Code;

WHEREAS, the Board of Trustees desires to amend the provisions of the Island Lake Village Code regarding schedule of fees, fines and penalties; and

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Island Lake, Lake and McHenry Counties, Illinois, as follows:

SECTION 1: Title 1, Chapter 16, Section 1-16-3, Schedule of Fees, Fines and Penalties, shall be amended as follows:

### 1-16-3 SCHEDULE OF FEES, FINES, AND PENALTIES

4-4-9G1	Temporary Water Meter Rental Charge	<del>\$5.00</del> <u>\$50.00</u> per day
4-4-9G2	Temporary Water Setup and Administrative Charge	<del>\$40.00</del> <u>\$50.00</u> , plus <del>\$7.50</del> <u>\$20.00</u> per 1,000 gallons used

SECTION 2: Severability. In the event that any section, clause, provision, or part of this Ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect.

SECTION 3: Repeal and Savings Clause. All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SECTION 4: Effective Date. This Ordinance shall be in full force and effect from after its passage and approval.
