ORDINANCE NO. 1675-23
An Ordinance Amending Title 7, 7-7-3 PROHIBITED PARKING AREAS
of the Village of Island Lake Code

WHEREAS, the Village of Island Lake is an Illinois municipal corporation in Lake and McHenry Counties and pursuant to the Illinois Municipal Code, the Village has the authority to modify the official Village Code; and

WHEREAS, The Board of Trustees desires to amend Title 7, Chapter 7, 7-7-3 *PROHIBITED PARKING AREAS of the Village of Island Lake Code*;

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Island Lake, Lake and McHenry Counties, Illinois, as follows:

SECTION 1: Title 7, Chapter 7, Section 7-7-3 PROHIBITED PARKING AREAS, shall be amended as follows:

7-7-3 PROHIBITED PARKING AREAS

- A. Except when necessary to avoid conflict with other traffic, or in compliance with law or the directions of a police officer or official traffic control device, no person shall:

[...]

8. No Parking Any Time on the Following Streets:

On the east side of Bassler Drive
Brier Court from Eastway Drive west to Brier Beach
Brierhill Drive north for one hundred feet (100') from Brier Court
Dorothy Court west from Island Drive
Eastway Drive from State Road (Route 176) to Burnett Road
Eastway Drive west side of street on unpaved easement to a point of fifty feet (50') north of Hill Court
Greenleaf Avenue east side of street between River Oaks Lane and Carriage Hill Road
Highland Drive from Hillside Drive to Charles Court
Hillside Drive from Highland Drive to Hyacinth Terrace
Newport Court east side of street from State Road (Route 176) to driveway at 545 Newport Court (entrance to Cotton Creek School)
Park Drive south from Fern Drive to Park Beach
South Shore Drive north side of street fronting South Shore Beach
Fern Drive east of Northern Court to Channel Park where posted

SECTION 2: Severability. In the event that any section, clause, provision, or part of this Ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect.

SECTION 3: Repeal and Savings Clause. All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SECTION 4: Effective Date. This Ordinance shall be in full force and effect on January 1, 2024.
