## ORDINANCE 1678-24

#### An Ordinance Amending Title 7, Chapter 13, Seizure and Impoundment of Motor Vehicles; and Title 1, Chapter 16, Schedule of Fees, Fines and Penalties of the Village of Island Lake Code

- WHEREAS, on January 11, 2024, the Village Board adopted Ordinance No. 1677-24 regulating Omnibus Drivers traveling within the Village corporate boundaries and the Village Board desires to amend said regulations to provide for the impoundment of vehicles driven in violation of said regulations;
- WHEREAS, 65 ILCS 5/11-42-6 gives the corporate authorities of non-home rule municipalities the ability to license, tax and regulate, and through such regulation, individuals and companies and corporations which employ such individuals whose actions without adequate notice to the municipality, will cause substantial cost, harm and damage; and
- WHEREAS, the Village Board has confirmed that it is in the best interests of the health, safety and welfare of the Village and its residents to adopt this Ordinance.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Island Lake, Lake and McHenry Counties, Illinois, as follows:

- SECTION 1: The foregoing recitals shall be and are hereby incorporated as findings of fact as if said recitals were fully set forth herein.
- SECTION 2: Title 7, Chapter 13, Seizure and Impoundment of Vehicles, Section 7-13-2, Public Nuisance Declared, shall be amended to add a new sub-section 12 to provide as follows: Operation or use of a motor vehicle by an Omnibus Driver, in violation of *Title 3, Chapter 15 of this Code* and the existing sub-sections 12 and 13 shall be renumbered accordingly.
- SECTION 3: Title 1, Chapter 16, Subsection 3, Schedule of Fees, Fines and Penalties, shall be amended as follows:

SECTION 4: Severability. In the event that any section, clause, provision, or part of this Ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect.

- SECTION 5: Repeal and Savings Clause. All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.
- SECTION 6: Effective Date. This Ordinance shall take effect immediately upon its passage and publication in pamphlet format, which is hereby authorized, due to the urgency of implementing an immediate regulation of unscheduled chartered transportation and drop-off of passengers in the Village.
