Place: Water Tower Park, 429 W. State Road

Date/Time: Sat., Sept. 28, noon; line up at 11:45am

Race distance: Thirty (30) yards

Winner: First dog to completely cross the Finish line

Award: Trophy and bragging rights as the 3rd Annual Island Lake

Dachshund Derby Winner

Registration deadline: September 20, 2024. Shot records must presented with registration form.

1. Dogs must be preregistered and sign in at the event by 11:30am.

- 2. Dogs must be purebred Dachshunds.
- 3. For the safety of dogs and attendees, *ALL* dogs must be leashed until the start of the race.
- 4. Dogs will be divided into age groups: 1 3 years, 4 6 years, 7 9 years (seniors)
- 5. Two dog handlers are required per dog: one to hold the dog at the **Start** and one to catch the dog at the **Finish Line**.
- 6. Dogs only on the race track. (You may not run with your dog.)
- 7. Dog handlers *may not* throw balls or toys during the race. (Bouncing of balls or toys allowed at the Finish Line.)
- 8. Dogs that jump the Start whistle *may be disqualified* at the judges' discretion.
- 9. Race judges will have the final call on the race winner. If the race is too close to call, judges may require a runoff.
- 10. Heat races may be required if the number of entrants is high.
- 11. Costumes are encouraged.

Oktoberfest Dachshund Derby

- 1. I hereby agree to abide by the rules set forth for the Dachshund Derby and acknowledge that participation in the Village of Island Lake Dachshund Derby is voluntary and I agree to the following.
- 2. I understand and acknowledge the risks and dangers to me and my dog associated with participating in the Village of Island Lake Dachshund Derby, including without limitation, the potential for serious bodily injury, permanent disability, paralysis and loss of life; loss of or damage to equipment and property; exposure to extreme conditions and circumstances; contact with other performers, participants, spectators, or other natural or manmade objects, acts of God, inclement weather, slips and falls, inadequate or defective equipment, failure in supervision or instruction, premises defects, horseplay, carelessness, lack of skill or technique, and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks"). I understand that these Risks may be caused in whole or in part by my own actions, inactions, the actions or inactions of others participating in the Event, or the negligent acts or omissions of the Released Parties defined below, and I hereby expressly assume all such Risks and responsibility for any damages, liabilities, losses, or expenses which I incur as a result of my participation in the Event.
- 3. I hereby Release, Waive, and Covenant not to sue, and further agree to indemnify, defend and hold harmless the Village and its elected officials, employees, contractors, and agents, police, fire and/or safety personnel of the Village, and the owners of the property on which the Event takes place; law enforcement and public safety agencies providing support for the event; and each of their respective officers, directors, partners, shareholders, members, agents, employees, and volunteers (Individually and collectively the "Released Parties"), with respect to any liability, claim(s), demand(s), cause(s) of action, damage(s), loss or expense (including court costs and reasonable attorneys' fees) of any kind or nature ("Liability") which may arise out of, result from, or relate in any way to my performing in the Event, including claims for Liability caused in whole or in part by the negligent acts or omissions of the Released Parties. I further agree that if, despite this Agreement, I, or anyone on my behalf, makes a claim for Liability against any of the Released Parties, I will indemnify, defend and hold harmless each of the Released Parties from any such Liabilities which may be incurred as the result of such claim.
- 4. I hereby agree that I, my assignees, heirs, distributes, guardians, next of kin, spouse, and legal representatives will not make a claim against, sue, or attach the property of the Village of Island Lake Illinois, or any of their affiliated organizations for injury or damage resulting from the negligence or other acts, however caused by any Director, employee, agent, or contractor of the Village of Island Lake as a result of my participation.

I understand that this Agreement represents the complete understanding between the parties regarding these issues and that if any provision of this Agreement is held to be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this Agreement and shall not affect the validity and enforceability of any remaining provisions.
