Filing Dates

Petitions

- The **first day to file** nominating petitions at the Village of Island Lake, 3720 Greenleaf Ave., Island Lake, IL 60042, is on **Tuesday, November 12, 2024 from 8:00 a.m. – 12:30 p.m. and 1:30 p.m. - 5:00 p.m.**** *The Village Office is closed daily from 12:30 – 1:30 P.M.*
- Regular Village Office hours for other filing days
- The **last day to file** is **Monday, November 18, 2024 from 8:00 a.m. – 12:30 p.m. and 1:30 p.m. - 5:00 p.m.**** *The Village Office is closed daily from 12:30 – 1:30 P.M.*

**Tuesday, November 12 and Monday, November 18, 2024, the Village Office will remain open, extending afternoon hours until 5:00 p.m. for petition filing. On other business days, petitions may be filed petitions during regular business hours:

8:00 a.m. – 12:30 p.m. and 1:30 – 4:30 p.m., Monday – Friday.

Those waiting in line when the Village opens at 8:00 a.m. on November 12 will be provided with a "simultaneous filer" receipt and will be placed into a lottery to determine the filing order. The lottery will be held on Thursday, November 21, 2024. Any petitions filed between 4:00 p.m. and 5:00 p.m. on November 18, 2024 also will be placed in a lottery to determine filing order. The lottery will be held on Wednesday, November 27, 2024.

Objections: Deadline for filing objects to nominating petitions is **Tuesday, November 25, 2024**. Objections may be filed Monday through Friday, 8:00 a.m. – 12:30 p.m. and 1:30 p.m. – 4:30 p.m.

Copies of petition packets and filing receipts can be requested from the Village Clerk.

The Village Clerk and staff cannot provide a review of nominating papers or legal opinions regarding petition papers. Prospective candidates are strongly encouraged to consult competent legal counsel regarding qualifications to seek office, preparation of petition papers, circulator requirements, signature

requirements, etc. After petition papers have been filed, pages cannot be amended or added. A receipt for filing the required Statement of Economic Interests may be added until 5 p.m. on the last day to file.

Calculating Minimum/Maximum Signature Requirements for Candidate Petitions

The **April 4, 2023 Consolidated Election Reports** from Lake and McHenry Counties are provided with the packets.

The Village has calculated the following signature requirements: Minimum signature requirements: 14; and maximum signature requirements: 64, *based on data provided courtesy of the Lake and McHenry County Clerks*. However, these calculations *should not be construed as legal advice*. Candidates should calculate minimum/maximum signatures independently according to the Illinois State Board of Elections formula and consult with legal counsel.
